



#### **JPAAC Updated Application Form**

To assist candidates with preparing for the next application process, the Justices of the Peace Appointments Advisory Committee is pleased to share the new <u>application form</u>.

Even though there are no vacancies currently advertised, the Committee is making the <u>application</u> form available now to give candidates an opportunity to review the questions and arrange for court observations in the regions they wish to apply.

The Committee encourages candidates to start court visits as soon as possible. Given the brief advertising period, it is important to plan ahead as you will need to attend 3 different types of courts where justices of the peace preside. The specific type of court you would like to observe may not always be scheduled so you may need to attend several times.
